# Decision on final candidate for inaugural head of National University Corporation Institute of Science Tokyo

The Joint Meeting for Selection of Head of National University Corporation Institute of Science Tokyo ("the Joint Meeting"), held on June 18, 2024, selected the final candidate for the inaugural head of National University Corporation Institute of Science Tokyo ("the Candidate") as below, in accordance with the Rules on Selection of Head of National University Corporation Institute of Science Tokyo ("the Rules").

## 1. Candidate's name and current position

Naoto Ohtake, professor and director-general of the Institute of Innovative Research, Tokyo Institute of Technology

#### 2. Term of office

From October 1, 2024, to March 31, 2028 (3 years and 6 months)

#### 3. Reasons for selection

In accordance with the Selection Criteria for the Inaugural Head of National University Corporation Institute of Science Tokyo ("the Criteria"), established by the Joint Meeting on February 22, 2024 and prescribing the qualities and capabilities expected of the inaugural head, the Joint Meeting comprehensively reviewed the nomination documents, statements of intent, biographies of all the candidates, and the outcomes of the related hearings and Q&A sessions.

Based on the above procedure, the Joint Meeting selected Naoto Ohtake as the Candidate, as he was judged to be the most suitable to lead the management of the integrated corporation, strongly satisfying the Criteria in the following ways:

- i. The Candidate presented a clear and inspiring vision to "create a better future through science," demonstrating foresight and presenting a well-structured, practical plan for the new university, including priority fields of research and the development of specialized personnel.
- ii. The Candidate has the qualities and track record necessary to take leadership in industryacademia collaborations, and more widely, international research networks.
- iii. The Candidate possesses the insight and passion expected of the inaugural head of an

organization aiming to establish "free and equal human relationships" and the foundation for academia that is open to society. He further has strong leadership skills, tactful communication capabilities, and a youthful vitality, all of which will be advantageous in forging a vibrant future for an international university of research excellence.

## 5. Decision to establish the position of provost

The Joint Meeting concluded that an organizational structure that firmly links management and academic affairs is essential for realizing the harmonious integration of Tokyo Medical and Dental University and Tokyo Institute of Technology, and for swiftly maximizing the benefits. Specifically, it is desirable to have a structure in which a president oversees the corporation and a provost oversees the university. Their respective duties and authorities should be clearly stipulated in relevant regulations that also mandate the involvement of an appropriate President Nomination and Scrutiny Committee in the procedure for selecting the president and appointing the provost.

At the time of the integration in particular, it is important that a candidate from one of the two universities serves as president of the integrated corporation, and one from the other university serves as provost of the new university, based on mutual understanding between the two universities. The president and the provost will cooperate on an equal footing and focus on creating a new type of university, which no other university in Japan has been able to achieve, as stipulated in the Basic Agreement on Integration of Corporations and Universities concluded between the two universities.

As such, the Joint Meeting has decided to establish the position of provost at National University Corporation Institute of Science Tokyo to strengthen its management and operations.
