

“The China State-Funded Postgraduate Overseas Study Program”  
Guidelines for Applicants to the Doctoral Program of  
Tokyo Institute of Technology commencing in September 2022

1. Outline:

Tokyo Institute of Technology is accepting applications to the Doctoral Program commencing in September 2022 under the “China State-Funded Postgraduate Overseas Study Program.” Selected candidates with excellent academic records will be exempt from application, enrollment and tuition fees.

2. Enrollment Date: Late September 2022

3. Type of Program: Doctoral Program

4. Number of Admitted Students: Several students in each Department

5. Eligibility Requirements:

Applicants must be Chinese nationals who satisfy the following conditions:

- (1) Applying as a student in the Doctoral Program under the “China State-Funded Postgraduate Overseas Study Program” of the China Scholarship Council.
- (2) Be expected to have completed a master’s degree program by the day before the enrollment date.

7. Application Deadline:

(Note that application documents must be received by the Admissions Division, Student Services Department on or before October 20, 2021.)

8. Selection Method:

(Selections for admission to Tokyo Institute of Technology will be based on a screening of the application documents and an online interview.)

9. Notification of Admission Decision:

Notification of the admission decision will be mailed to each applicant in January 2022. Selected candidates with excellent academic records will receive at the same time a Letter of Confirmation from Tokyo Tech indicating that they may be exempted from paying tuition and other fees. This letter is required when such students subsequently apply to the China Scholarship Council for the “China State-Funded Postgraduate Overseas Study Program.”

10. Application Fee, Enrollment Fee and Tuition:

As stated in item 9 above, selected candidates with excellent academic records may be exempted from paying application, enrollment and tuition fee charges at Tokyo Institute of Technology. All other accepted students who wish to enroll in the Doctoral Program must pay the application fee and the enrollment and tuition fees as required during the admissions procedure.

Application fee: 30,000 yen

Enrollment fee: 282,000 yen

Tuition: 635,400 yen/year

Note: Selected candidates' exemption from application, enrollment and tuition fees will be finalized only after they are chosen to be recipients of the China Scholarship Council's scholarship. Even if they have received the Letter of Confirmation and been recognized as having excellent academic records, if a selected candidate fails to be chosen for the CSC scholarship, the offer of exemption from tuition and other fees will be withdrawn, and the student must pay all tuition and fees.
