1. IMS will not be held liable for the results of the Immigration Bureau's decision towards the application, nor any final decisions made by the Immigration Bureau over the entire screening period, nor can IMS assure the length of time required by the Bureau to process the application.
2. We will not ask the Immigration Bureau to provide an examination status update unless two months or more have passed since the initial application date.
3. Applicants are required to pay the application agency fee (except for applications paid by the university) and revenue stamp fee in cash.
4. Applicants will promptly submit any additional required documents if so requested by the Immigration Bureau after submission of this application.
5. Applicants agree to promptly report to IMS any changes in the information contained in this application as they occur, at any time during the application process.
6. IMS will keep the passport and residence card until the process has been completed. In principle, we will not temporarily return your passport and resident card while they are in our custody. If you need your passport or resident card during the application process, please submit your application yourself at the immigration office. (Except for the application for Certificate of Eligibility.)
7. Applicant acknowledges that the application may be considered void if any information contained herein is incorrect or falsified in any manner.
8. Application will be submitted to the Immigration Bureau in a timely manner after all necessary processing has been carried out at the IMS office. Please note that we do not submit application documents on the day of the receipt.
