# 2023 Spring Semester Special Medical Screening for Students

The special medical screening for students engaged in handling ionizing radiation, as mandated by the Law Act on Control of Radioisotopes, etc., will be conducted as follows. **Book online in advance** and take the special screening If you are applicable.

# 1. Students required to take the screening

Bachelor's degree students who belong to a laboratory, master's and doctoral degree students including RAs and TAs, and research students who are/will be engaged in handling ionizing radiation (categorized under A or B of the initial education and training).

- Category A: Handling unsealed radioisotopes
- Category B: Using radiation generators or synchrotron radiation facilities or handling sealed radioisotopes Using X-ray apparatus or NMR apparatus in radiation controlled areas Using external facilities such as High Energy Accelerator Research Organization, SPring-8, Japan Atomic Energy Agency, National Institute of Radiological Sciences or RIKEN etc. for the above purposes

- Interview sheet about ionizing radiation
  - · Answer all the questions. Ask the academic advisor for help if there is any difficulty filling out the sheet.
  - For department, write the name of the department of the academic supervisor.
  - · Leave the "screening no. " blank.

# 6. What to expect in the screening

Blood test, doctor's health interview.

\*New registrants and students using facilities off campus(KEK, Spring-8,etc) cannot omit the blood test.

# 7. Results of the screening

The results of the screening will be sent to the academic advisors via campus mail delivery in about 1 month.

<sup>\*</sup>Category C is not applicable to take the screening.

#### 8. Important notice

- ① If either of the conditions below apply, do not come the venue.
  - You fall under the restrictions for the novel coronavirus established by the institute.
  - You have symptoms such as a fever above 37.5°C, cough, and severe fatigue.
- ② All students must book online in advance. You may not take the screening without booking.
- ③ Wear a non-woven mask at the venue.
- ② Fill out the interview sheet about ionizing radiation in advance.
- \* For those who do not have a special medical screening card, should book online and come to the reception on time. Follow the instructions given at the reception and fill out the documents.
