2025 Spring Semester Special Medical Examination for Students of Science and Engineering

The special medical examination for students engaged in handling ionizing radiation, as mandated by the Law Act on Control of Radioisotopes, etc., will be conducted as follows. **Book online in advance** and take the special medical examination if you are applicable.

1. Students who are required to take the examination

Bachelor's degree students who belong to a laboratory, master's and doctoral degree students including RAs and TAs, and research students who are/will be engaged in handling ionizing radiation (categorized under A or B of the initial education and training).

- Category A: Handling unsealed radioisotopes
- Category B: Using radiation generators or synchrotron radiation facilities or handling sealed radioisotopes Using X-ray apparatus or NMR apparatus in radiation controlled areas Using external facilities such as High Energy Accelerator Research Organization, SPring-8, Japan Atomic Energy Agency, National Institute of Radiological Sciences or RIKEN etc. for the above purposes

*Category C is not applicable to take the examination.

2. Date

Ookayama Campus: Friday, April 18 and Monday, April 21

Suzukakedai Campus: Friday, April 11 PM and Monday, April 14 AM

3. Location

Ookayama Campus: Media Hall and Collaboration Room, West Building 9, Floor 2 Suzukakedai Campus: S1 Building, Floor 1 Lobby (Reception), Room 106 (Blood test, etc)

*Note that the venue has been changed for Suzukakedai campus!

4. Online booking Starting Thursday, April 3

Book online from Tokyo Tech Portal Educational Services "Medical Checkup for Students".

The time slots are all mixed gender.

Choose "Special Medical Examination Spring 2025" from the menu of the booking system.

5. What to bring

- Special medical examination card
 - · Check student ID and date of birth, etc. Correct misprinted data in red if any.
- Interview sheet about ionizing radiation
 - Answer all the questions. Ask the academic supervisor for help if you have any difficulty answering the questions.
 - For department, write the name of the department of the academic supervisor.
 - · Leave the "examination no. blank.

6. What to expect in the examination

Blood test, doctor's health interview.

*New registrants and students using facilities off campus (KEK, Spring-8,etc.) cannot omit the blood test.

7. Results of the examination

The results of the examination will be sent to the academic supervisors via campus mail delivery in about 1 month.

8. Important notice

- ① If you are sick with fever, cough, etc., reschedule your reservation and do not come to the venue. It will affect your blood examination data if you take it when you are sick.
- 2 All students must book online in advance. You may not take the examination without booking.
- ③ Fill out the interview sheet about ionizing radiation in advance.
- * For those who do not have the special medical examination card, come to the reception.

 Note that it will take some time since documents must be fill out and registration online is necessary.

The data collected from the medical examination will be managed by the Student Healthcare Center and shared to the Radiation Safety and Management Center, for the purpose of health and safety management.
