

## Notice Regarding Makeup Examinations

Important:

There are two kinds of makeup exams.

1. Those scheduled and conducted by course instructors at their discretion
2. Those coordinated and conducted by the Student Division

**This notice pertains to the second case. For the first case, students should contact the instructor directly.**

Students who cannot take the quarter-end exam due to the reasons listed below must ask the instructor in charge if a makeup exam has been scheduled by the Student Division. If so, students must then receive permission from the instructor to request to take the exam at the Student Division office.

Acceptable reasons

- 1) Medical reasons not subject to an authorized absence or transportation delays

Students requesting makeup exam(s) due to transportation delays are required to submit a slip confirming the bus/train delays (遅延証明書) issued by the public transport operator. For requests due to medical reasons, the Student Division will ask for information necessary for verification. Requests for makeup exams will not be accepted without supporting documents or verification.

- 2) Conflicting exams

Those who have quarter-end exams scheduled at the same time on the same day must ask the Student Division in advance which exam they are to defer and later make up.

- 3) Authorized absence

Authorized absence during the quarter-end exam period and handling of makeup exams

Refer to “Agreement on Authorized Absences at Tokyo Institute of Technology” to determine if a Request for Authorized Absence is required.

If the Request for Authorized Absence form is required, please submit it to the Student Division as early as possible. Please also directly inform your course instructor(s) about your absence from the quarter-end exam.

- 4) Reasons other than those listed above (i.e., unforeseen circumstances )

Students are required to submit a relevant certificate verifying the occurrence.

\* **Unacceptable reasons:** Studying abroad, internship, job hunting, club activities

To request taking a makeup exam, visit our office during the following period.

Period: **January 20 to 5:00 p.m, February 3, 2025**

- \* If you are not able to come to the office in person, contact the Undergraduate Services Group by email during the abovementioned period.
- \* We will not consider requests after the stated period.

Please be sure to contact the Student Division immediately if something comes up preventing you from taking a quarter-end exam. If you are unable to notify us during the request period, your request will still be considered if submitted **by 5:00 p.m, February 12**. Should you miss this deadline due to unavoidable circumstances (such as hospitalization), please contact the Student Division for advice **by 11:00 a.m. February 13**. However, your request cannot be guaranteed.
