- ただし、2021年9月以降、標準修業年数を超え在学し、授業料免除を希望する場合は、その理由について判定し可否を決定しますので、後期に web 申請と理由書(本人および指導教員)の提出を行ってください。
- 理由書の審査により、前期・後期で免除判定が異なることがあります。

Please be sure to submit this form at the Primary Submission

1) Students who enrolled in April 2018 and earlier

• Applications for exemption from tuition made for the spring semester will continue to be valid for the fall semester as well.

- However, if you are applying for exemption from tuition while studying at Tokyo Tech for longer than the standard duration of study, the reasons for exceeding the standard duration will be separately reviewed for each semester. A statement of the reasons must be prepared separately by the applicant and his/her academic supervisor and submitted for each semester concerned. Online pre-application is also required for each semester.

(Please note that these statements will be reviewed, and a decision on exemption made, for each semester separately, which may result in different decisions for the spring and fall semesters.)

2) Students who enrolled in September 2018

• Applications for exemption from tuition made for the spring semester will continue to be valid for the fall semester as well.

- However, if your studies at Tokyo Tech exceed the standard duration of study after September 2021 and you wish to be exempted from the tuition payment, the reasons for exceeding the standard duration will be reviewed for the fall semester. A statement of the reasons must be prepared separately by the applicant and his/her academic supervisor and submitted for the fall semester. Online pre-application is also required for the fall semester.

(Please note that these statements will be reviewed, and a decision on exemption made, for the fall semester, which may result in different decisions for the spring and fall semesters.)
